

## Multi-State Educational Attainment Academy Michigan Action Plan Overview

At the invitation of SHEEO, the Michigan Association of State Universities (MASU – the four-year public university trade association) invited key stakeholders, including a representative of the Governor, to attend the launch of the Attainment Academy in October 2019. Many of the participants had been involved in a prior extensive stakeholder process facilitated by the Michigan College Access Network's Higher Education Attainment Roundtable (MIHEART), resulting in the 2018 Total Talent report. In addition to the seven stakeholders who attended the initial October 2019 workshop, representatives of three other organizations were invited to subsequent planning meetings and provided input in the drafting of this Action Plan – as did a number of additional staff members of participating organizations. Participant list is included in Appendix A.

Current attainment rate: 45.5% Goal: 60% by 2030

#### **Attainment Priorities**

In the process of developing this Action Plan, particularly in light of the COVID disruption, the team decided to focus on three Priorities.

#### **Level II Priorities**

These priorities were discussed by the team in meetings from October, 2019 – February, 2020. They were identified as lower priority, and thus less time was devoted to strategy development. They warrant additional focus as COVID recovery strategies are implemented.

# 1. Increase the proportion of youth with postsecondary credits/credentials earned prior to high school graduation

• A subcommittee of MIHEART should consider leading a cross-sector stakeholder discussions of policy barriers, analyze data to determine where access and equity gaps are greatest, and address K12 concerns about expansion.

#### 2. Accelerate entry into and completion of credit-bearing courses for students in need of remediation

- o MDE and Detroit Drives Degrees should lead in expanding successful high school programming such as transition courses that reduce the need for remediation.
- o MCCA's Center for Student Success should continue to provide technical assistance to community colleges in scaling up the implementation of credit-bearing course placement policies that utilize multiple-measures and accelerated remedial course designs (such as co-requisite).
- o MASU and MICU should benchmark 4-year university policies regarding placement and remedial course design, and share best practices.
- The MI Partnership for Academic Transitions (MCAN/MCCA) will provide funding for six partnerships of high schools and colleges to significantly accelerate this work.

## 3. Increase readiness for and enrollment in postsecondary education for students with disabilities

- o In partnership with the MI Transition Association and employers, MDE and schools should expand transition services for students with disabilities.
- o Best practices among K12 schools should be identified, documented, and shared across the state.
- An innovation grant program or other funding mechanism should be established to enhance services provided across the state.

## 4. Streamline the transfer process and increase the success rates of transfer students

- o Continue the implementation of the MiTransfer Pathways, statewide multi-sector articulation agreements, including the 12 adopted in the first two phases. Continue and expand faculty work groups to grow the number of transfer pathways.
- o Leverage existing partnerships to increase broad transfer agreements beyond the pathways.
- o Invest in marketing transfer programs and pathways to high school students, CC students, and adult learners
- o Market and expand Credit for Prior Learning programs at all IHEs to increase the number of students benefiting.

#### 5. Create state-institutional partnership to implement Complete College America college completion strategies

 To dramatically increase institutional implementation of Complete College America and other research-based college completion strategies, the State or Philanthropy should establish an incentive fund to reward institutions for success.

## **Stakeholder & Community Engagement**

Early in 2000, the Department of Labor and Economic Opportunity began developing a Sixty by 30 Alliance and engaging in outreach with stakeholders around the state. This was put on hold due to the COVID-19 pandemic, as state priorities shifted toward emergency shutdown and planning for subsequent reopening of education facilities. Each of the participating entities has engaged stakeholders within their own communities and will continue to do so on an ongoing basis through regular interaction of participating entities. A communications strategy and plan for engaging a broader set of stakeholders will be developed for implementation once the COVID-19 pandemic has subsided. Regional and statewide strategies will be developed.

#### **Attainment Agenda Sustainability**

Progress toward the action steps identified in this Action Plan will be tracked and accounted for by the Michigan Association of State Universities (MASU), and will be a regular and consistent discussion item for the Michigan Higher Education Attainment Roundtable (MIHEART), which serves as a voluntary convening body facilitated by the Michigan College Access Network. The establishment of a "Sixty by 30 Office" housed within the state's Department of Labor and Economic Opportunity has been temporarily postponed in light of the state's focus on contending with the COVID-19 pandemic. At the point in time that the office is established, strong coordination will occur between it, the MIHEART activities, and other key stakeholders.

## **Metrics and Progress Tracking**

Progress on the attainment goals can be tracked specifically with each underlying action. MICU and MASU staff developed an Excel project management tool that will be used for tracking progress. Further, the MCAN's recently launched "Impact Map" will serve as one visual representation for tracking progress on a number of college access and attainment metrics statewide and for communities around the state (<a href="https://micollegeaccess.org/news/impact-map">https://micollegeaccess.org/news/impact-map</a>). The Center for Educational Performance and Information (<a href="https://www.michigan.gov/cepi/">https://www.michigan.gov/cepi/</a>) has likewise begun discussions on expanding the ways it publicly reports metrics on public higher education institutions. Discussions will continue among the stakeholders on additional ways that Michigan stakeholders can monitor and report on attainment progress in a visually appealing and user-friendly manner.
